- Committee Liaison positions** will be appointed by the presiding ROAAOMS Officers (President, Vice President and Immediate Past President). Applicants must have served previously on the ROAAOMS Executive Committee.
- The Vice President position** will be appointed by the AAOMS Board of Trustees based on the recommendation provided by the Officers of ROAAOMS. Applicants must have served previously on the ROAAOMS Executive Committee and have at least 18 months of OMS training remaining.
- Non-categorical OMS residents will not be eligible to serve on the Executive Committee.
