



## Exhibitor Liability Insurance Program

In addition to being able to provide exhibitors with insurance, Rainprotection will be collecting and verifying all insurance certificates on behalf of AAOMS, regardless of the insurer, are verified for compliance.

As a standard requirement for all exhibitors, it is necessary to provide proof of general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance coverage is not optional.

This insurance must be in force during the lease dates of the event, September 26 - October 3, 2021, naming the American Association of Oral and Maxillofacial Surgeons (9700 W. Bryn Mawr Ave., Rosemont, IL 60018) as the certificate holder. The following must be named as additional insured:

- American Association of Oral and Maxillofacial Surgeons and 2021 AAOMS Annual Meeting (9700 W. Bryn Mawr Ave. Rosemont, IL 60018)
- Music City Center (201 Fifth Avenue South, Nashville, TN 37203)
- Global Experience Specialists, Inc (7000 Lindell Road, Las Vegas, NV 89118)

## Workers' Compensation/Employers Liability

As a standard requirement based in the state you are domiciled in, you are required to provide proof of workers' compensation insurance with limits not less than \$1,000,000 for each occurrence, so long as your organization is required by applicable state law to hold workers' compensation insurance. This insurance cannot be purchased from Rainprotection Insurance.
