Dear Chairmen Blunt and Cole and Ranking Members Murray and DeLauro:

The undersigned organizations as supporters of the Friends of National Institute of Dental and Craniofacial Research (FNIDCR) urge you to oppose President Trump's fiscal year (FY) 2018 budget request which recommends an unprecedented 20 percent cut to the National Institutes of Health (NIH) and a major reorganization of its institutes of centers. We also urge you to oppose the Administrations' recent proposal to cut \$1.2 billion from NIH in the current fiscal year to pay for an increase in defense and the wall along the Mexican border. These proposals set a dangerous precedent.

Last year, Congress overwhelmingly and on a bipartisan basis approved the 21st Century Cures Act which reauthorized NIH for three years and provided targeted increased funding to bring cures to all Americans. Congress already indicated its strong support for all the NIH institutes and centers through this law. A reorganization at this time would seriously disrupt ongoing research and slow progress towards finding cures and more effective treatment options that will lead to better health for everyone.

FNIDCR is steadfastly committed to supporting the National Institute of Dental and Craniofacial Research (NIDCR) and the unique, vital and innovative role it plays in funding research to create less invasive, cost-effective and more efficient ways to improve oral health and lessen the economic burden dental, oral and craniofacial diseases and conditions place on Americans.

We are extremely grateful that Congress provided the most significant increases in funding for NIH and the National Institute of Dental and Craniofacial Research (NIDCR) in over a decade in the FY2016 appropriations bill. We hope you can continue this trend in FY2017 by providing NIH and NIDCR with sustained and

increased investments over time including at least \$34.1 billion for NIH and \$430.5 million for NIDCR and at least a \$2 billion increase for NIH over FY2017 levels and \$452 million for NIDCR in FY2018.

Dentists, researchers, students and the American public rely on the research funded by the NIDCR. For example, research in community water fluoridation has saved the American public at least \$38 for every \$1 invested. Increasing funding for NIDCR is the only way to ensure that these life-changing initiatives continue. Additionally, it is a critical step to improving the oral health of the nation and reducing the societal costs of dental care.

Finally, it is vitally important that Congress honors the long-standing tradition of allocating resources to the entire biomedical research enterprise at NIH, including all the institutes and centers. Funding provided via the 21st Century Cures Act should be used to supplement—not supplant—the core funding of NIH. Importantly, a discovery in one area of research may be applied to another. Maintaining flexibility, honoring the scientific peer-review process and supporting all research is critical to our endeavor to bring cures to Americans.

We look forward to working with you to ensure the highest funding level possible for NIDCR is enacted into law this year. We greatly appreciate your leadership thus far to help make this a reality.
