Dear Senators Cardin and Wicker,

On behalf of our collective members, we are writing to express our support for S. 359. This bill would allow full-time faculty members participating in the Dental Faculty Loan Repayment Program (DFLRP) to exclude from income the amount of the loan forgiveness from their federal income taxes.

The DFLRP program\* was created to help CODA accredited academic dental institutions recruit and retain qualified faculty in dental schools and approved residency and advanced education programs in general, pediatric, or public health dentistry. A critical factor in recruiting and retaining dental school faculty is the staggering level of student loan debt and income disparity with private practice.

We are pleased that Congress understands the importance of this program. Because of your support, new dental faculty loan repayment grant cycles were initiated by the Health Resources and Services Administration (HRSA) in fiscal years 2016, 2017 and 2018. Programs may support loan repayment contracts over five years to recruit and retain faculty. Full-time faculty members are eligible for repayment of 10, 15, 20, 25 and 30 percent of their student loan balance (principal and interest) for each year of service.

The DFLRP program is making a real impact in recruiting and retaining dental faculty. And by alleviating the tax burden of the loan repayment benefits, S. 359 will make the program even more effective.
